LOCALLY GROWN VEGETABLES, FRUITS, JAMS, A VARIETY OF BREADS, PIES AND BAKED GOODS, MEATS, FISH, SHRIMP, DAIRY PRODUCTS, ITALIAN ICE, MAPLE SYRUP, HONEY, FLOWERS, DECORATIVE PLANTS ARE SOLD, DEPENDING ON THE SEASON. CRAFT VENDORS SELL A VARIETY OF HAND MADE ITEMS. THE SVIA OVERSEES THE MARKET AND SETS UP A TENT EACH WEEK. FRESH COFFEE IS PROVIDED FOR A SUGGESTED DONATION. ATTENDANCE CAN BE UP TO 600 PEOPLE ON A GIVEN SATURDAY. THE WINTER MARKET HOURS ARE 10AM TO 1PM. IN THE WINTER, THE MARKET IS LOCATED IN THE VELVET MILL. THE SAME VENDORS PARTICIPATE IN THE WINTER MARKET, ALTHOUGH SOME DON'T ATTEND IF THEY DON'T HAVE PRODUCT OVER THE WINTER. THE VENDORS PAY A FEE TO PARTICIPATE IN THE MARKET, WHICH IS USED TO PAY THE OPERATING AND MARKETING EXPENSES OF RUNNING THE MARKET. THE SVIA PROVIDES ENTERTAINMENT FOR CHILDREN DURING THE WINTER.
